


Detailed overview of the situation of the countries of the region in terms of progress made and challenges that remain pending in implementing the Millennium Development Goals

"Shaping the Future of Social Protection: Access, Financing and Solidarity"


- Orientation of development based on the normative framework provided by civil, political, economic, social and cultural rights






PARTICIPANTS BY COUNTRY OF ORIGIN, 2004-2005 BIENNIUM

Extrabudgetary resources: over 180 projects implemented



Number of projects under way, 2004 – 2005 biennium, by project cluster














MODERNIZATION OF LIBRARY SERVICES
