## ANNOTATED PROVISIONAL AGENDA





## **A. BACKGROUND AND OBJECTIVES**

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary body of the Economic Commission for Latin America and the Caribbean (ECLAC) that brings together government representatives to monitor compliance with international and regional agreements on gender equality and to promote the incorporation of the gender perspective and the guarantee of women's human rights in public policies in countries of the region, in order to make progress towards women's autonomy.

At their fifty-sixth meeting, held on 5 and 6 October 2017 in Havana, the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean agreed to convene their fifty-seventh meeting at ECLAC headquarters in Santiago.

The fifty-seventh meeting of the Presiding Officers will be devoted to outlining preparations for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean (Santiago, 2019), and presenting and reviewing progress of the working group on the regional fund in support of women's and feminist organizations and movements, among other matters.

**4. Report on the United Nations Joint Global Programme on Essential Services for Women and Girls Subject to Violence**

Under this agenda item, representatives of Guatemala, Panama, Peru and Uruguay will share their country's experiences in incorporating internationally agreed standards on a multisectoral approach to address violence against women. This will be followed by an opportunity for questions and comments.

**5. Report of the working group on the regional fund in support of women's and feminist organizations and movements**

Further to the agreements contained in paragraphs 10 and 11 of resolution 6(XIII) adopted at the thirteenth session of the Regional Conference on Women in Latin America and the Caribbean and agreement 15 of the fifty-sixth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, the representative of Mexico will present a progress report on the working group on the regional fund in support of women's and feminist organizations and movements.

Following this, the delegations of the countries and specialized agencies and other organizations of the United Nations system will have the opportunity to make statements.

**6. Preparations for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean (Santiago, 2019)**

In fulfilment of the request set forth in agreement 14 of the fifty-sixth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, the secretariat will present a road map for the preparatory process for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean, which will be held in 2019 in Santiago. After the presentation, the floor will be offered to country delegations wishing to make statements, followed by the funds, programmes and specialized agencies of the United Nations system.

**7. Discussion on women's autonomy in changing economic scenarios in the framework of preparations for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean (Santiago, 2019)**

Pursuant to agreements 9, 13 and 14 of the fifty-sixth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean and as a contribution to the discussion on the theme to be addressed at the fourteenth session of the Conference, a discussion will be held on women's autonomy in changing economic scenarios. Following an initial introduction on the theme, women ministers from Latin America will present their views in the first session. The second will focus specifically on the Caribbean perspective and the third will be devoted to the views of women parliamentarians from the region, with the support of ParlAmericas.

**8. Other matters**

Under this item, delegations will consider any other issues they may wish to raise.

**9. Adoption of agreements**

The Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean will consider and adopt the agreements of their fifty-seventh meeting.
