Fifty-eighth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean

Santiago, 22 and 23 January 2019

ANNOTATED PROVISIONAL AGENDA





A. BACKGROUND AND OBJECTIVES

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary body of the Economic Commission for Latin America and the Caribbean (ECLAC) that brings together government representatives to monitor compliance with international and regional agreements on gender equality and to promote the incorporation of the gender perspective and the guarantee of women's human rights in public policies in countries of the region, in order to make progress towards women's autonomy.

At their fifty-seventh meeting, held on 30 and 31 July 2017 in Santiago, the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean agreed to convene their fifty-eighth meeting at ECLAC headquarters in Santiago.

At their fifty-eighth meeting, the Presiding Officers will make progress with the preparations for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean (Santiago, 4–8 November 2019) and exchange views on the country reports on the implementation of the Montevideo Strategy for Implementation of the Regional Gender Agenda within the Sustainable Development Framework by 2030 and its synergy with the review of the implementation of the Beijing Declaration and Platform for Action (Beijing+25), as well as the annotated index of the position document of the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean, among other matters.

As set forth in the Montevideo Strategy for Implementation of the Regional Gender Agenda within the Sustainable Development Framework by 2030, the governments will have the opportunity to report voluntarily on their progress in the implementation and adaptation of the Strategy.

The countries should provide brief oral reports on the activities carried out since the adoption of the Montevideo Strategy.

There will also be a discussion on the preparation of voluntary reports on progress in the application of the Montevideo Strategy for the Implementation of the Regional Gender Agenda within the Sustainable Development Framework by 2030, and its synergy with the review of the implementation of the Beijing Declaration and Platform for Action (Beijing+25), with a view to the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean.

This will be followed by an opportunity to make statements.

6. Presentation of the annotated index of the position document of the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean (Santiago, 4–8 November 2019)

The secretariat will present the annotated index of the position paper for the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean, to be held in Santiago from 4 to 8 November 2019.
