



## "Old age protection in Latin America: lessons learned for other developing countries"

07th of December 2010

03.30 – 05.30 p.m. at BMZ Bonn (conference room A)

#### Concept of the event

The event shall depict key experiences with old age protection systems in Latin America and discuss the potential transferability for other developing countries in Asia and Africa.

At first, the global challenge of ageing and the need for decent old age protection systems will be presented by Dr. Helmut Schwarzer (ILO). Afterwards, major insights from last year's conference "Growing old with dignity" in Lima (Peru) and the subsequent report "Envejecimiento en America Latina" (editors: Antonio Prado/ Ana Sojo) will be presented by Ana Sojo (ECLAC).

The successive panel will discuss if and how the Latin American experiences in terms of old age protection can be useful and transferable for other developing countries in Asia and Africa. Good practices and possibilities for development cooperation to support the implementation of old age protection systems should be identified as well as barriers and key factors hindering the establishment of universal old age protection coverage. The panel will consist of Dr. Prasetijono Widjojo (Deputy Minister for Economic Affairs, National Development Planning Agency, BAPPENAS, Government of Indonesia), Astrid Walker Bourne (Head of Policy Help Age International), Ana Sojo (ECLAC) and Dr. Matthias Rompel (Head of Social Protection Unit). It will be hosted by Dr. Helmut Schwarzer.

Particularly relevant points to be discussed are: possibilities to increase old age protection coverage among informal sector workers, possibilities to extend current pension systems (mainly social insurance), the role of tax-financed social pensions as well as market-based solutions such as "micropensions". Besides pension financing, further factors being relevant to the welfare and social protection of older people in developing countries shall be analyzed such as access to health protection and societal participation.

The event will take place in English language.
