



# Development Account

- ▶ Capacity development programme of the United Nations Secretariat aiming at enhancing capacities of developing countries
    - ▶ Priority areas of the UN Development Agenda
  - ▶ Every biennium, a new tranche
    - ▶ Change of subject matter focus
  - ▶ Tranche 9: 2014–2015
    - ▶ Rio+20 and IADGs
    - ▶ MDG

- ▶ Current status of the 9<sup>th</sup> tranche:

*“The proposed programme budget for the year of 2014–2015 has been submitted for approval to the General Assembly's Fifth Committee. It amounts to 28.4 million USD comprises 46 projects. The budget is currently under review by the General Assembly.”*

# General Information about the Project

- ▶ Joint project with ESCAP, ECLAC is the implementing organization
- ▶ Time frame: 2014–2017 (3 years)
- ▶ Title: “Strengthening statistical capacities for building macroeconomic and sustainable development indicators in Latin America, the Caribbean and Asia–Pacific countries”
  - ▶ SNA 2008 and SEEA 2012 implementation
- ▶ 10 pilot countries
  - ▶ 6 from the LAC region
    - ▶ Brazil, Colombia, Guatemala, Jamaica, Paraguay, Uruguay
- ▶ Total budget: USD 860.000
