## **A. BACKGROUND AND OBJECTIVES**

The Presiding Officers of the Regional Council for Planning of the Latin American and Caribbean Institute for Economic and Social Planning (ILPES) meet every two years to review the progress of work and fulfilment of the resolutions adopted by the Council, the main intergovernmental body steering the work of the Institute.

At its seventeenth meeting, held in Montevideo on 29 and 30 August 2019, the Regional Council for Planning elected the following Presiding Officers:

Chair:	Uruguay
Members:	Argentina, Cuba, Dominican Republic, Jamaica, Panama and Paraguay
Host country:	Chile

This is the first meeting of the Presiding Officers currently serving. They will continue to serve as such until the next meeting of the Regional Council for Planning, to be held in the second half of 2021.

The provisional agenda for the twenty-eighth meeting of the Presiding Officers, which will be held in virtual format given the context of the coronavirus disease (COVID-19) pandemic, is presented below.
