





IX ECLAC Seminar on Trade and Sustainability International trade as a driver for sustainable development

July 18 and 19, 2018

This event is a follow-up of a series of annual ECLAC seminars on International Trade and Climate Change, which took place since 2009. These seminars have had two objectives: *i*) identify how trade can contribute to the mitigation of climate change and promote sustainable development, and *ii*) support the incorporation of sustainability standards in Latin American exports to promote its competitiveness in international markets. The seminars have contributed to inform Latin American stakeholders about global trends regarding standards, impact measurement methodologies and environmental requirements that prevail in the main export markets, as well as sharing best practices regarding sustainable export trends and discussing strategies to adapt to these new market conditions.

The audience of these events are public and private stakeholders linked to the export sector in Latin America and the Caribbean, including representatives of ministries of trade, environment, economy and agriculture, among others; trade promotion agencies; export associations, associations of producers and universities. Moreover, experts from various countries of the European Union, the United States and the Republic of Korea have participated in the seminars.

This year's Seminar focuses on those aspects of trade in goods and services that can contribute to the fulfillment of the sustainable development goals (SDGs), with emphasis on environmental, labor, social and gender issues. These potential synergies are reviewed in the context of the 2030 Agenda for Sustainable Development, with a specific focus on regulations and sustainability standards in trade agreements and the business sector. Other issues to be addressed are environmental and social sustainability criteria in global value chain operations and the growing demand from consumers in developed countries.

Presentations and debates generated in each of the three sessions will provide inputs for policy dialogue on how to incorporate sustainability criteria into the region's export strategies and strengthen public-private partnerships oriented towards these sustainable development goals.
