Preliminary agenda

Introduction

The Regional Water Dialogues 2023, organized by the Economic Commission for Latin America and the Caribbean (ECLAC), will take place at its headquarters in Santiago de Chile in a hybrid format (onsite and virtual) from Wednesday the 1st to Friday the 3rd of February 2023. The event is part of the regional preparatory process for the [UN Water Conference 2023](#), which aims to assess progress related to SDG 6 (water and sanitation) in the framework of the ["Mid-term comprehensive review of the activities of the International Decade for Action "Water for Sustainable Development" \(2018-2028\)](#), and launch a **Regional Water Action Agenda**.

Objectives

The objectives of this event are i) to analyze the progress of SDG 6 with respect to the commitments acquired, to accelerate its implementation in Latin America and the Caribbean (LAC) and move towards a sustainable and inclusive water transition; and ii) exchange experiences and lessons learned to achieve the objectives of the Decade of Action for Water 2018-2028; and iii) launch a regional agenda for action for water with a multi-stakeholder approach.

Structure and Contents

The sessions of the Regional Water Dialogues 2023 are oriented along the thematic lines that will be carried out at the [UN Water Conference 2023](#): i) Water and Climate; ii) Water and Sustainable development; iii) Water and Financing; iv) Water and cooperation; v) Water, energy and food. High-level national authorities will participate in each of them. In addition, there will be technical sessions to discuss water solutions at various scales to accelerate the achievement of SDG 6 under the water valuation initiative. During the Dialogues, the capacity-building project ROSA: Water Sustainability Network and Observatory will be launched.

Reasoning

Water is a vital element for the fulfilment of the 2030 Agenda. ECLAC identified through open consultations that [LAC's water priorities](#) are to strengthen governance and institutions, ensure access to safe drinking water and sanitation, and incorporate nature-based solutions, which require partnerships and cooperation to accelerate the implementation of SDG 6. Therefore, ECLAC promotes spaces for dialogue and exchange in the framework of the Decade of Action for Water 2018-2028 and calls on the countries of the region to share their progress on water issues, in order to share experiences, mobilize cooperation and provide concrete solutions to move towards a sustainable and inclusive water transition.
