Introduction

The 2024 Regional Water Dialogues, organized by the Economic Commission for Latin America and the Caribbean (ECLAC), will take place at the headquarters of the Inter-American Institute for Cooperation on Agriculture (IICA), San José, Costa Rica, in hybrid format (in person and virtual), on March 11, 12 and 13. The event, which integrates a high-level ministerial space, as well as exchanges of technical experiences with a multi-stakeholder approach, is part of the regional process to promote good practices and promote the achievement of SDG 6 in the region.

Goals

Within the framework of the voluntary commitments of the 2023 *Regional Water Action Agenda*, the objectives of this event are: i) analyze the progress and challenges of achieving SDG 6 and ii) highlight successful experiences and lessons learned for the achievement of the same objectives.

Justification

ECLAC promotes spaces for dialogue and exchange within the framework of the Decade of Action for Water 2018-2028 and calls on the different actors of the countries in the region to share their progress in water matters, to innovate, mobilize cooperation, and financing, in addition to replicating, scaling and providing concrete solutions to promote a sustainable and inclusive water transition.

Structure and contents

The sessions are structured according to the priority areas identified in the *Regional Water Action Agenda* adopted in the 2023 Regional Water Dialogues held in Santiago, Chile in February of that year. In each of these sessions, high-level national authorities, private sector members, academia, and civil society will participate.

This edition will have a special session on **water and agriculture**, as well as a space aimed at socializing and analyzing the Regional Process in preparation for the **2024 World Water Forum**, which summarizes the main challenges and proposals for action to address the water challenges in the region.
