Lessons from Latin America and the Caribbean: biodiversity mainstreaming & governance for transformative change

Context

As countries move into the adoption and then implementation phase of the post-2020 GBF, there is a new set of challenges to foster the catalytic potential of mainstreaming biodiversity throughout productive, economic and financial sectors and of the governance for transformative change in favor of biodiversity. Biodiversity mainstreaming and governance for transformative change have been two of the topics identified by experts from the region in different dialogues co-organized by ECLAC as key tools for multidimensional progress towards the 2030 Agenda, advancing in pathways to address challenges in a more coherent, integral, sustainable and fair development systems.

Latin America and the Caribbean has a rich experience of practices for the mainstreaming of biodiversity and innovative governance in favor of biodiversity from the local to the regional level, yet experiences that contribute to improving the state of biodiversity through its sustainable use are not sufficiently identified, recognized or studied. At a critical moment in which it is necessary to overcome inertia, silos, be ambitious and move into transitions to nature-positive systems, ECLAC and Expertise France propose to reflect on the main findings, lessons learned and good practices that could be up-scaled, building also on experiences from innovative cases from other regions and from key stakeholders to start an inter-regional dialogue.
