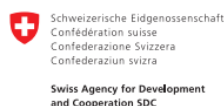

The annual report [Latin American Economic Outlook](#), known as LEO, is jointly produced by the OECD Development Centre, the United Nations Economic Commission for Latin America and the Caribbean (ECLAC), the Development Bank of Latin America and the Caribbean (CAF) and the European Commission. Each edition conducts a structural analysis of the region's socio-economic context, considering its challenges and opportunities for improved development.

The 16th edition, *“Investing in Sustainable Development”* proposes pathways to boost investment towards a more sustainable development through coordinated actions of the public sector, the private sector, and international partners. The report provides recommendations for implementing a new investment agenda considering the region's productive potential, the strategic sectors that can create quality jobs, the opportunities associated to the green and digital transitions, and the key role of governance and institutions, financing, and international partnerships.

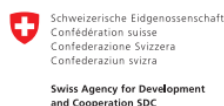
