#### Connect to include: Opportunities for meaningful connectivity

#### Background

The launch of the EU-LAC Digital Alliance presents significant opportunities to strengthen cooperation between the European Union (EU) and Latin America and the Caribbean (LAC), adopting a human-centered and rights-oriented approach to digitalization. LAC has made significant progress in connectivity and digital transformation led by its governments with plans and programs aimed at digital inclusion for all as well as the growing deployment of 5G technology. However, as the benefits that people obtain from being connected increase, the cost of not being connected to the network and to digital opportunities also increases.

The European Union and Latin America and the Caribbean share important common values in connectivity (human-centered, inclusive, accessible, affordable). Bilateral cooperation can benefit from lessons learned and best practices in both regions. For example, the EU has developed the European Union Toolbox for Connectivity that provides recommendations and lessons learned that have the potential to facilitate implementation and investment in innovative technologies, such as very high-capacity networks (VHCN), including fiber and 5G. In LAC, Mexico in collaboration with the German government has developed a guide to facilitate the implementation of 5G in the areas of greatest economic impact through the strengthening of the value chain. Both initiatives are considered a valuable experience and input for policy makers in LAC.

During the EU-LAC Digital Alliance conference held in Cartagena de India's from November 27 to 29, 2023, several opportunities for EU-LAC cooperation on connectivity, regulation, and deployment of new technologies (such as 5G) were identified. Agreements were made to continue the discussion at the technical level and to undertake a series of cooperative activities in the framework of the EU-LAC Digital Alliance. This session on Connectivity and Inclusion, within the framework of the preparatory meeting for the Ministerial Conference on the Information Society, aims to advance the cooperation and technical dialogue in this field and to establish the co-leadership role of Mexico and Ecuador, initiated during the EU-LAC Digital Alliance Days in Cartagena de Indias, Colombia.
