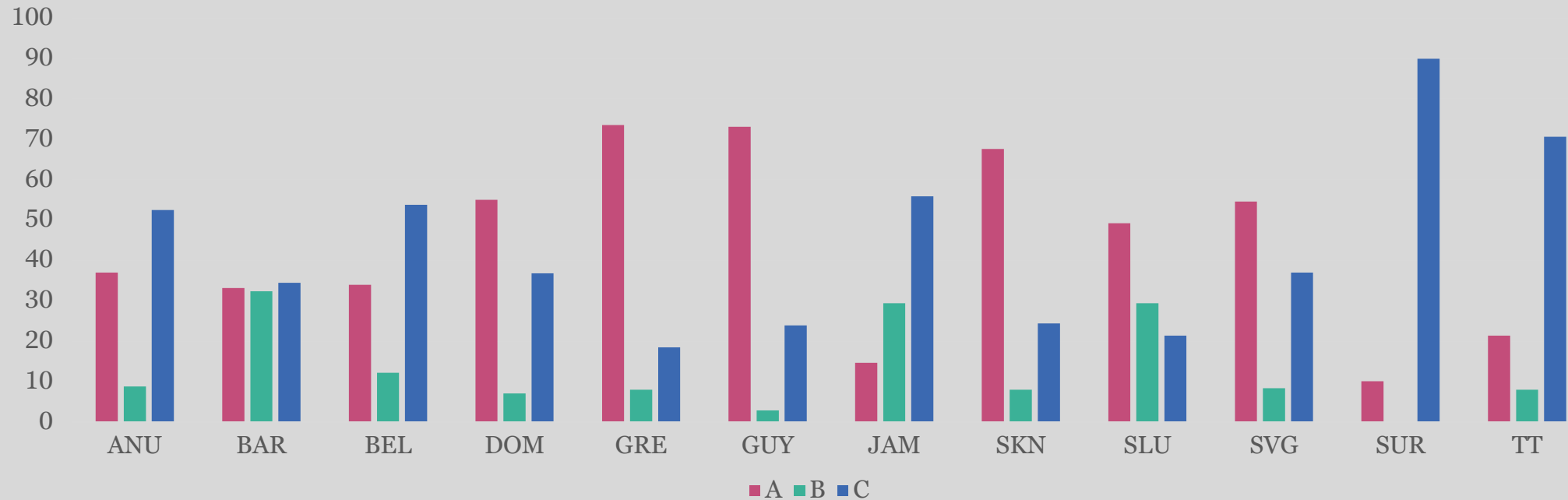

## % SHARE OF CATEGORIES A, B, C

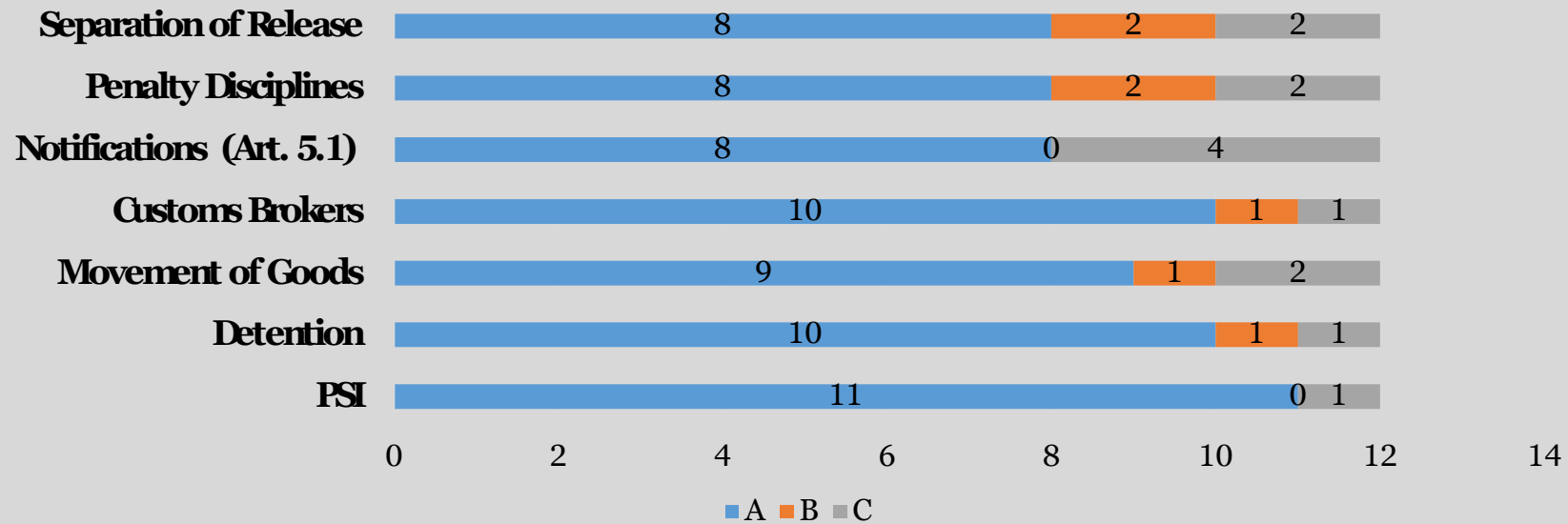

### **PACE OF IMPLEMENTATION (based on notified implementation commitments)**

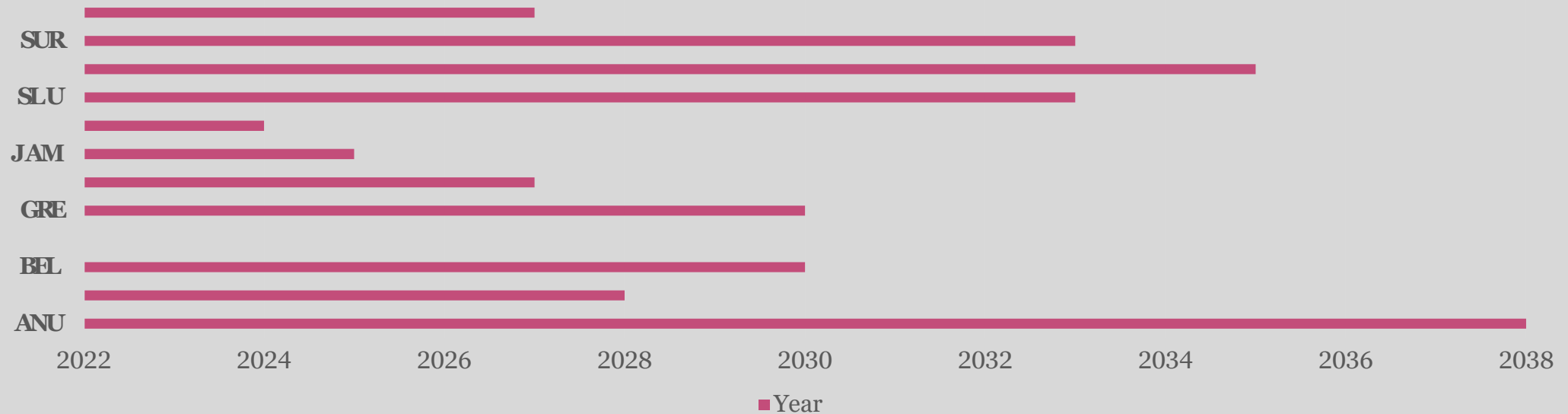

# ***THE CARICOM TF AGENDA & STRATEGY***

## **LEVERAGING TFA IMPLEMENTATION TO:**

- ✓ Support and drive regional integration and trade facilitation reforms through harmonised and co-ordinated actions.
- ✓ Improve trade performance and enhance foreign market access;
- ✓ Improve regional business environment; reduce time and cost of doing business.
- ✓ Fulfil international obligations on Trade Facilitation (EPA, TFA);
- ✓ Rationalise and co-ordinate donor engagement and interventions for ongoing trade facilitation reforms in CARICOM.
- ✓ Harness regional expertise for TACB support;
- ✓ Support the achievement of the Community's strategic goal of Economic Resilience (improve competitiveness, attract FDI, integrate into regional and global VCs)



# THE CARICOM TF AGENDA & STRATEGY

## MANDATES

- ✓ Prioritise co-operation on TF in bilateral arrangements with hemispheric trading partners;
- ✓ Adopt a co-ordinated regional approach to TFA implementation ;
- ✓ Utilise regional approaches, where appropriate, to minimise/rationalise TFA implementation costs;
- ✓ Co-ordinate mobilisation of donor resources and TACB to support implementation;
- ✓ Establish CARICOM Regional Committee on Trade Facilitation (RCTF) to oversee regional co-ordination;
- ✓ CCS to monitor, provide support, and mobilise TACB support for national and regional implementation

### AGREEMENT ON TRADE FACILITATION

MINISTERIAL DECISION OF 7 DECEMBER 2013

The Ministerial Conference,

Having regard to paragraph 1 of Article IX of the Marrakesh Agreement Establishing the World Trade Organization (the "WTO Agreement");

Decides as follows:

1. We hereby conclude the negotiation of an Agreement on Trade Facilitation (the "Agreement"), which is annexed hereto, subject to legal review for rectifications of a purely formal character that do not affect the substance of the Agreement.
2. We hereby establish a Preparatory Committee on Trade Facilitation (the "Preparatory Committee") under the General Council, open to all Members, to perform such functions as may be necessary to ensure the expeditious entry into force of the Agreement and to prepare for the efficient operation of the Agreement upon its entry into force. In particular, the Preparatory Committee shall conduct the legal review of the Agreement referred to in paragraph 1 above, receive notifications of Category A commitments, and draw up a Protocol of Amendment (the "Protocol") to insert the Agreement into Annex 1A of the WTO Agreement.
3. The General Council shall meet no later than 31 July 2014 to annex to the Agreement notifications of Category A commitments, to adopt the Protocol drawn up by the Preparatory Committee, and to open the Protocol for acceptance until 31 July 2015. The Protocol shall enter into force in accordance with Article X:3 of the WTO Agreement.

Regional or Sub-regional Trade Information Portal	<ul style="list-style-type: none"><li>▪ Transparency</li><li>▪ Publication of TFA-required information.</li><li>▪ Regional enquiry point</li></ul>
Regional Electronic Risk Information Exchange	<ul style="list-style-type: none"><li>▪ Rapid and secure exchange of risk information.</li></ul>
Regional Risk Management System	<ul style="list-style-type: none"><li>▪ assess regional-level threats and risks</li><li>▪ develop and communicate common risk criteria to CARICOM members</li><li>▪ monitor and evaluate results</li></ul>
Accredited Regional labs and testing bodies	<ul style="list-style-type: none"><li>▪ Designate accredited laboratories in CARICOM region authorized to carry out confirmatory tests for goods imported to any CARICOM member</li></ul>



# REGIONAL SUPPORT INITIATIVES

## Regional Activities

Legal	Model harmonized legislation
Administrative/ Operational Support	Model harmonized SOPs Model harmonized forms + documents Guidelines for establishment/operation of national administrative bodies
Capacity Building	Regional training programs, sharing of experience and expertise and regional best practices.
Regional Coordination	Regional committees - monitor and provide technical guidance

- **NCTFs** - National Co-ordination
- **OECS Commission** - Sub-regional co-ordination
- **CARICOM Secretariat** - Regional co-ordination

- ✓ *Regional harmonized policy and institutional frameworks to support TF – Customs, SPS, TBT, MASA;*
- ✓ *Harmonised Regional quality infrastructure;*
- ✓ *Some advances in the automation and digitalization of trade procedures and documents;*
- ✓ *OECS Economic Union reform initiatives;*
- ✓ *Regional Co-ordination – Monitoring; TACB mobilization; Information and experience sharing through the RCTF;*





## SOME HEADWINDS....



- ✓ *Slow legislative reform process in Member States*
- ✓ *Infrastructure investment (ICT, risk assessment including certification bodies and testing labs etc.)*
- ✓ *Border Agency co-ordination*
- ✓ *Regional Transportation infrastructure and connectivity;*
- ✓ *CSM implementation gaps*
- ✓ *Public-private dialogue and Private Sector engagement*
- ✓ *National co-ordination and monitoring of commitments (NTFCs);*
- ✓ *Donor engagement.*
