



This work gauges the state of the art and examines the variety and breadth of policy interest in the territorial sphere. The outcome indicates that, rather than policies, the appropriate term is a cluster or family of territorial development policies. In practice, however, this family lacks the desirable cohesion and coordination, and thus needs to be consolidated into an ecosystem. A model for analysis —Territorial
