### DESCRIPTION OF REQUIREMENTS

#### ENGLISH VERSION

The United Nations Economic Commission for Latin America and the Caribbean (ECLAC) invites companies with local representation in Chile with experience in waterproofing, exterior works and sewerage installation to participate in the execution of the "Interventions and Waterproofing of ECLAC's Water Pond" Project.

This bid comprises 2 stages, the first one whose objective is to carry out interventions to the water pond of an approximate surface of 3300 m<sup>2</sup>, consisting of pipe repairs, installation of equipment and construction of a concrete water pond curb. The second stage consists in the installation of a cement-based waterproof coating for the pond.

#### VERSION ESPAÑOL

La Comisión Económica para América Latina y el Caribe de las Naciones Unidas (CEPAL) invita a empresas con representación local en Chile con experiencia en obras de impermeabilización, obras exteriores e instalación de alcantarillado a participar de la ejecución del Proyecto "Intervenciones e



Impermeabilización del Espejo de Agua de la CEPAL".

La presente licitación comprende 2 etapas, la primera cuyo objetivo es la de realizar intervenciones a espejo de agua de una superficie aproximada de 3300 m<sup>2</sup>, consistentes en reparaciones de tuberías, instalación de equipamiento y construcción de un pretil de borde. La segunda etapa consiste en la impermeabilización a su fondo mediante un revestimiento impermeable cementicio.

## EOI INSTRUCTIONS

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace ([www.ungm.org](http://www.ungm.org)) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

#### **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
