Persons with disabilities in World Population & Housing Census Programme

2020 World Population and Housing Census Programme resolution recognizes population and housing censuses as a source of data designed to generate valuable statistics and indicators for assessing the situation of various special population groups, such as persons with disabilities (ECOSOC Res. E/RES/2015/10)

- Global data compilation and dissemination



Regional/sub-regional meetings on disability statistics

- Objectives and participation
 - compilation of national experiences
 - enhance the sharing of national experiences and practices in the measurement of disability
 - foster discussions among national statisticians and policy experts on national data needs for monitoring inclusive development
 - (i) East/South East Asia, (ii) the Caribbean, (iii) Africa, (iv) Arabic speaking countries, (v) North and Central Asia and the Western Balkan States, and (vi) Latin American countries
 - 133 participants from national statistical offices and disability policy government agencies of 90 countries

Compiling official statistics on disability

- o UNSD compiled recent disability data/metadata from 106 countries/areas
- Developed data-portal and disseminate data for wider accessibility through UNSD website
 - United Nations Disability Statistics Data Portal https://unstats.un.org/unsd/demographicsocial/sconcerns/disability/statistics/#/home
- o Information on prevalence, socio-demographic and economic characteristics, living arrangements and living conditions
 - Type of disability*
 - Marital status
 - Educational characteristics (literacy, attendance, attainment)*

 - Economic characteristics (usual status, occupation, status in employment)
 Living arrangements (household vs institution*, type and size of hhd)
 Quality of amenities available to the housing unit (drinking water supply, bathing facilities, type of toilet, lighting for housing unit)

Lessons learnt

- More countries collected data on disability during 2010 than in 2000 round
 - More availability of data on disability
 - However, still wide variations in estimates of disability both among countries
- Still substantial differences among countries in questions used - with implications for the quality and inter-country data comparability







Some conclusions and recommendations

- In regional meetings, some participants recognized that adaptation to national circumstances, rather than adoption, of international measures of disability may be necessary mainly based on outcomes of their testing and piloting in countries
- Also, in the context of producing internationally comparable data on disability, participants some participants raised the issue of how national priorities for measurement of disability can be harmonized with regional and international priorities
