- ▶ Population: 321, 115 (mid-year est. 2011)
- Pop. Growth Rate: 2.056 %, 2010
- GDP per capita: US\$4,200 2010

Youth Profile

Youth in Belize falls within age range 15 - 29

According to 2010 Census -27% of the population $\sim 84,501$ are youth

- •Females 13.4%
- •Males 14.1%

95 % net primary school enrollment 50.2% net secondary school enrollment

Unemployment Rate (Census 2010)

- •14- 19 years 49.7%

Snapshot Sexual and Reproductive Health

▶ Teen Fertility Rate: 73/1000

Adolescent Birth Rate: 64/1000 (15-19 years)

▶ Contraceptive Prevalence Rate: 55.2/1000

▶ Unmet need for Contraception: 16.2/1000

Snapshot Sexual and Reproductive Health

- Decrease in maternal mortality from 134 in 2005 to 0 in 2011 due to implementation of quality improvement initiative under the Safe Motherhood Programme.
- Improvements in the provision of commodities for reproductive health care in the public health system
- Improvements in the provision of youth friendly prevention services within Government and Civil Society Organizations.
- Integration of HFLE into the primary schools curriculum

Situation of HIV and AIDS

- Estimated adult HIV prevalence rate: 2.1%
- HIV prevalence among 15-24 years antenatal clinic attendees 0.81%
- In 2011 newly reported HIV cases 226 (119 males and 107 females) representing a 7.4% decrease when compared to the 244 cases in 2010
- Young people age 15-29 represented 37% of the newly reported HIV cases

Situation of HIV and AIDS

Public health sector has provision of free ARVs

- As of end of 2011, a total of 1,358 PLHIV receiving ARVs
- For 2011 92.2% of pregnant mothers tested for HIV as a part of the PMTCT programme
- All exposed infants received treatment at delivery and got tested prior to their discharge from the hospital

SRH and Youth

Sexually Transmitted Infections Rate (MOH 2011)

15-19 years $\sim 17.2/1000$

20-24 years $\sim 38.6/1000$

 $25-29 \text{ years} \sim 43.1/1000$

Condom Use

Number of young persons age 15-24 years who reported use of condom at last sex with non-regular sex partner 71.7% (Sexual Behavior Survey, 2009)

Coordinating, Monitoring and Accountability Mechanism

Multi-sectoral bodies were established to coordinate and monitor the national response as it relates to SRH and HIV and AIDS

- National AIDS Commission
- National Committees for Families and Children
- National Women's Commission
- National Gender based Violence Committee
- National Sexual and Reproductive Health Committee

Organization of Services

Non-Governmental Facilities:

- BFLA an SRH service provider, showed highest levels of SRH and HIV integrated programme planning and management
 - Outreach in rural areas
 - Voluntary testing and Counselling (VCT)
 - Provider-initiated testing and Counselling (PITC)
 - Gender-based Violence Comprehensive Services (GBV)
 - Management of formal referral system to/from other NGOs, MCH Clinics and public hospitals

Organization of Services

Public Health Facilities

- Public health service providers at the primary, secondary and tertiary levels reorienting SRH and HIV services to allow for bi-directional integration
- Implementation of PMTCT Guidelines
- HIV services most often integrated into SRH are VCT into Family Planning and PITC and prophylactic treatment into PMTCT
- Condom distribution integrated into Family Planning and STI services
- Gender-based Violence integrated into emergency services

Organization of Services

- Private Health Facilities (User fees)
 - SRH services were being reoriented to include HIV services – informing clients about confidentiality and routine HIV testing
 - Family Planning services
 - Sexually Transmitted Infections
 - PMTCT services

INTERVENTIONS: IN-SCHOOL YOUTH

- Establishment of an Health and Family Life Education (HFLE) unit within the Ministry of Education, Youth and Sports: Dedicated staff
- Integration of HIV into the HFLE Curricula

- Adaptation of modules and resources
 "Together We Can"-Red Cross,
 "You, Your Life, Your Dreams"- (Family Care Int'l, UNFPA,
 CARICOM)
- Peer Education Programme in Secondary and Tertiary Schools (Facilitate referrals to available services)
- Annual HIV and AIDS prevention training for teachers

INTERVENTIONS: In-School Youth

- Integration of HIV and AIDS prevention into Secondary Schools' Life Skills Programmes (HIV awareness week, Red Ribbon Day)
- > Annual HIV Testing Day University of Belize

- ► AIDS Link Newsletter Cornerstone Foundation
- Conflict Resolution and Anger Management Sessions in High-Schools
- Stigma and Discrimination Sessions with High School Students
- Behavioral Change Campaign targeted messages to delay early sexual activity

INTERVENTIONS: UNATTACHED YOUTH

Violence Reduction and HIV and AIDS Prevention Programmes:

- Establishment of a dedicated Violence Reduction and HIV Unit within the Ministry of Youth
- Establishment of a Conscious Youth Development programme for former and present gang members
- HIV and AIDS prevention and treatment programme within the prison
- ➤ HIV and AIDS prevention programme, including the creation of youth friendly spaces, within the male and female youth hostel
- Non-traditional skills training and empowerment for teen mothers and at risk young women

INTERVENTIONS: UNATTACHED YOUTH

Entrepreneurship and HIV and AIDS Prevention

Programme:

- Jewelry and drum making skills and HIV awareness and condom negotiation
- Barber Shop and Beauty Salon Condom Distribution Programme (YWCA)

Low literacy Sexual and Reproductive Health Peer Education Program (Global Fund)

- Peer Education Out-reach Activities
- Use of satellites tables

Mass Media Campaign

• Behavioral Change Campaign for safer sexual practices and partner reduction

Edutainment Program

- Creative Expression and Advocacy Work-shops
- Open Mic Spoken Word poetry slams

Best Practices

Sexual and Reproductive health programmes and services:

- HFLE in primary schools
- Out-of –school youth
- Incarcerated youth
- Persons with disabilities
- Indigenous youth

Challenges

- Promoting the right to health and healthy living including SRH rights for young people
 - Access to services for youth under 18 without parental consent
 - Changing perception of males to improving health seeking behavior
 - Absence of an integrated approach to adolescent health services
 - Comprehensive integration of life skills into secondary schools
 - Leveraging greater allocation of resources for the health sector in rural communities
- Evidenced-based policy decisions and planning

Way Forward

- Legal and Policy review and development of a model legislation for adolescent access to SRH and HIV services
- Greater integration to SRH and HIV into services for men/women across the life cycle
- Strengthen the continuum of care for HIV
- Development of HFLE Curriculum for secondary and tertiary schools through the Ministry of Education
- Advocacy for greater allocation of resources in rural communities
- National Condom Policy
- National Youth Policy pending approval
