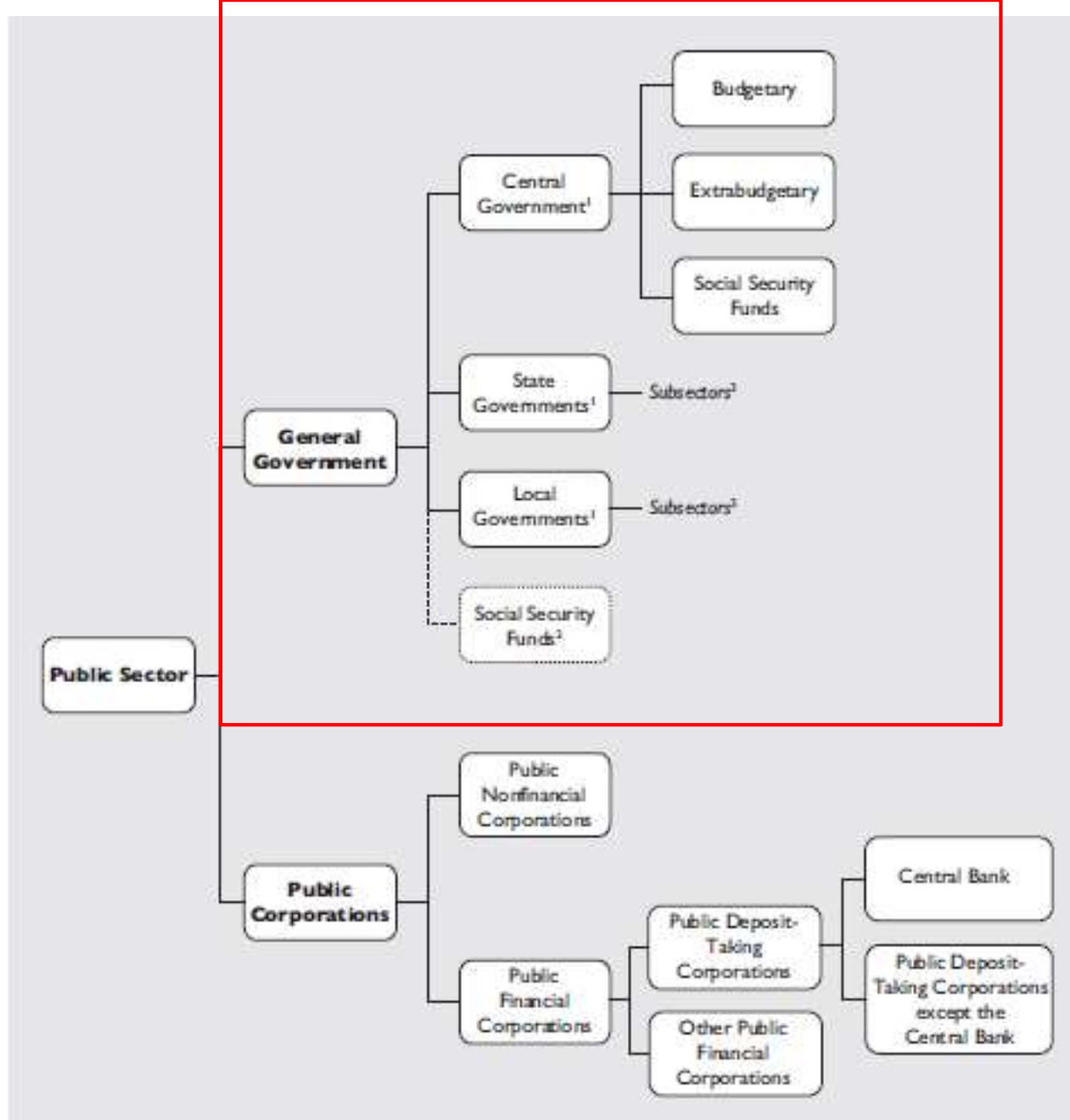

General Government

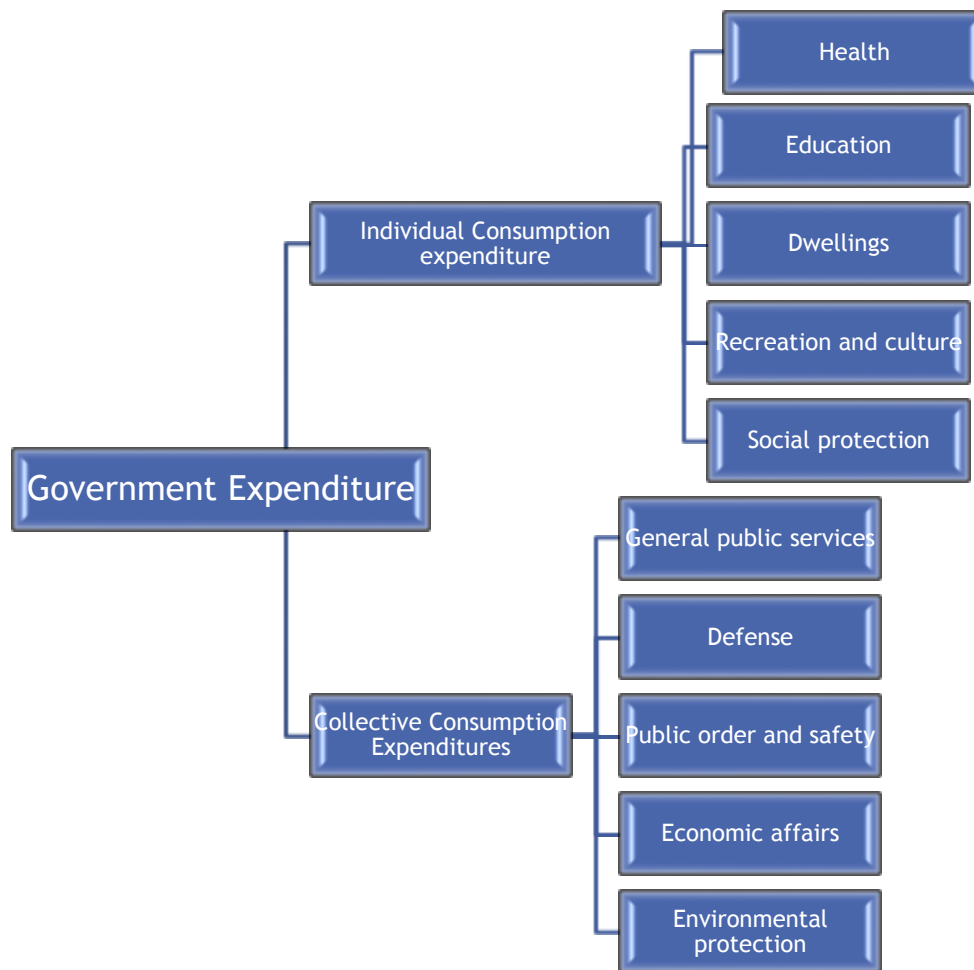
- ▶ Government units are unique kinds of legal entities established by political processes that have legislative, judicial or executive authority over other institutional units within a given area. Viewed as institutional units, the principal functions of government are to assume responsibility for the provision of goods and services to the community or to individual households and to finance their provision out of taxation or other incomes, to redistribute income and wealth by means of transfers, and to engage in non-market production...

Special instructions: Health

Choose public hospitals of the highest complexity. They must have at least these specializations: Internal medicine; Surgery; Pediatrics and Obstetrics-Gynecology.

The hospitals required must be universal general care hospitals. **Specialized hospitals will not be taken**

Except for the position of Hospital Administrator, all other occupations must not have positions of head office, seniority between 5-10 years in the position.

Indicate the city where the information is collected.

❑ Some considerations

- ▶ Hospital administrator **Does not require a doctor**
- ▶ Medical Doctor. **Internist.**
- ▶ Medical specialists **Pediatrician, gynecologist, general surgeon or cardiologist**
- ▶ Hospital nurse **Work in general medicine or internal medicine.**

Special Instructions: Education

In those countries where there is no single scale for teachers, emblematic or prestigious schools within public education will be chosen. If they provide primary and secondary education, information will be requested from the director of secondary education, secondary school teacher and primary school teacher.

In addition, if there is differentiated remuneration within the primary and secondary levels, the remuneration of the teacher of the first grade of each cycle (secondary and primary) will be taken.

If the remunerations are differentiated according to the subject they teach, the remunerations of a Language teacher will be taken, this is the subject corresponding to the official language of the country, in the first grade of each cycle of the secondary.

Except for the position of director, all other occupations must not have positions of chiefs, seniority between 5-10 years in the same position. Indicate the city where the information is collected.

❑ Some considerations

- ▶ Professor of Secondary Education. **First year of the cycle - Language**
- ▶ Teacher of Primary Education **First year of the cycle - Language**
- ▶ University Professor **Full-time, holder or principal, most important State University, Faculty of Law, Civil or Roman Law Chair**

Special Instructions: Collective Services

Indicate at what level of government the information is collected

It is suggested to collect the information in the Ministries of: Finance, Labor, Justice and / or Economy.

Except for the position of managerial staff, all other occupations must not have positions of chiefs, seniority between 5-10 years in the same position. Indicate the city where the information is collected.

❑ Some considerations

- ▶ Government Statistics: **Sampling professional of National Institute of Statistics.**
- ▶ Judge: **Only criminal or civil area, who is NOT a member of the Supreme Court or Appeal.**
- ▶ Government Economist: **Economist of National Accounts.**

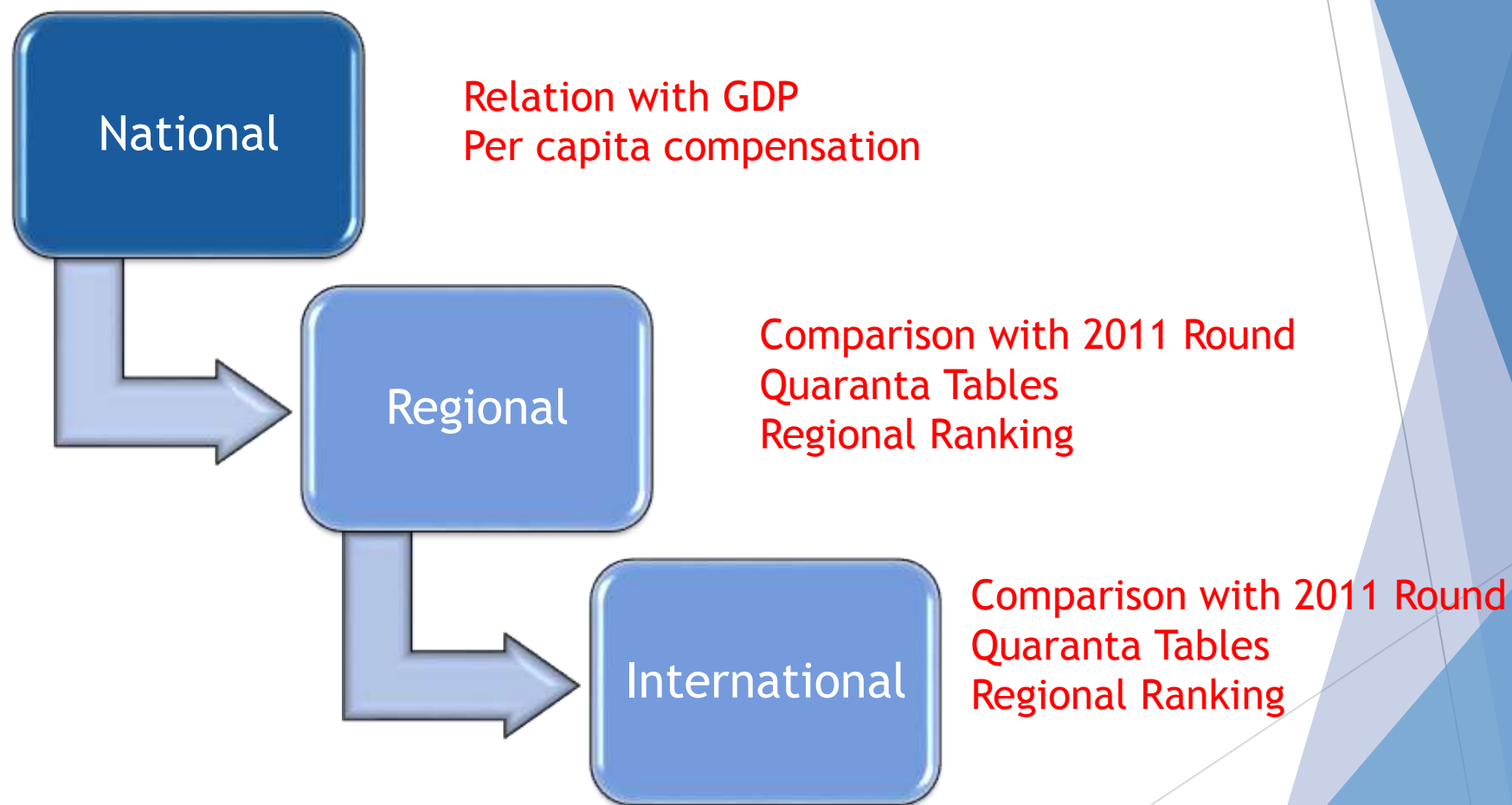

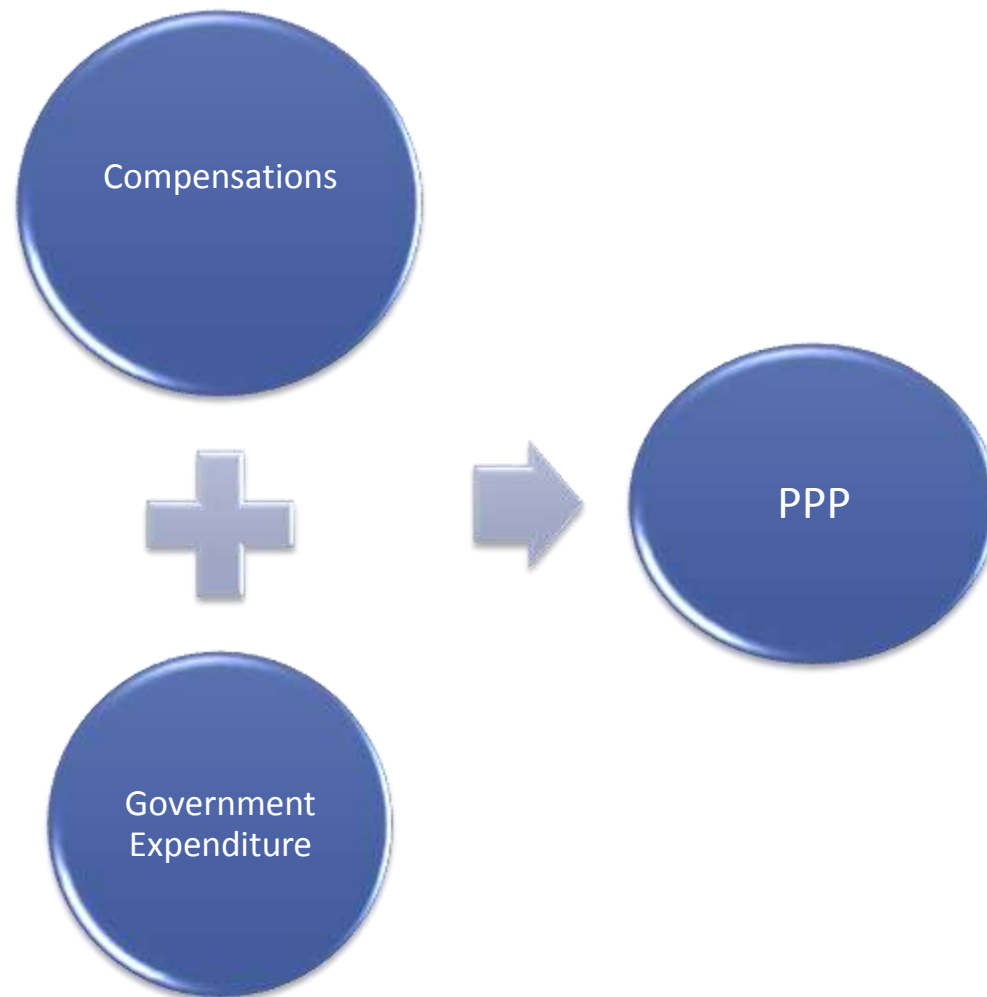
