- 2. Improving opportunities and outcomes for skilled migrants
  - Support for new migrants
  - Increasing contextual knowledge and intelligence
  - Information on employment opportunities
  - Mentorship
  - Direct employment



# WHAT ROLE FOR POLICY?

- Managing skilled migration
- Legs. & Regs. for an entrepreneurial ecosystem that creates a nexus between youth and diasporans
- Role of embassies as nodes of support, information & contacts
- Premigration preparation and support
- Engage migrants post-migration (e.g. investment opps at home, philanthropy)
- Increase quality and quantity of migration data



## HOW... WHAT ROLE FOR POLICY?

- Affirm Caribbean Single Market and Economy (CSME) towards intraregional/South-South skilled migration
- Equipping youths through education...
  - for mobility
  - of a global citizen
  - towards more cultural confidence
- Recognise links across different policy spaces
  - E.g. migration, youth, disaster risk reduction and development



### HOW... LEARN FROM THE PRIVATE SECTOR
