# **Background**

Health is a fundamental human right and a key pillar of individual well-being. However, health systems in Latin America and the Caribbean face a context marked by structural challenges such as chronic underfunding, segmentation of health services, and fragmentation of the population based on their ability to pay. These factors generate and reproduce inequalities both in access to and outcomes of healthcare. These issues have been persistent over time, leading to systems that operate with poor coordination, inefficiencies, and a lack of solidarity, which in turn makes it difficult for people to access the benefits and services offered by health systems (Marinho, Dahuabe, and Arenas de Mesa, 2023).

In this context, the Economic Commission for Latin America and the Caribbean (ECLAC) has emphasized the urgency for countries in the region to move toward a universal health model, upholding the principle of "leaving no one behind." Sustainable Development Goal (SDG) 3 promotes Universal Health Coverage (UHC) with financial protection, ensuring timely access to comprehensive health services for the entire population. Achieving this goal requires a significant increase in health investment. In Latin America and the Caribbean, public health expenditure averaged 4.4% of Gross Domestic Product (GDP) in 2021, a figure still below the 6% of GDP recommended by the Pan American Health Organization (PAHO/WHO) (Marinho, Sugg, and Farías, 2025).

In addition to increasing health investment, it is necessary to reorganize the operation of health systems to make them more efficient, with particular emphasis on the role of Primary Health Care (PHC). The implementation of PHC is recognized as the most cost-effective strategy to ensure that services are accessible and equitable, allowing all people to receive timely, high-

















quality care without discrimination. This contributes to reducing inequalities and improving the population's quality of life (ECLAC/PAHO, 2024).

It is also important to move forward with multisectoral strategies involving health systems and other areas of social protection, such as education, employment, and housing, in order to address the social determinants of health in an integrated way.

Progressing toward universal health is not only an ethical imperative, but also a necessary condition for sustainable development and social cohesion in the region. In this context, Panel IV aims to provide space for the exchange of national experiences regarding strategies designed to advance universal health in the region.
