THE ESCAZU AGREEMENT

• Art. 15: Conference of the Parties:

4) At the First Meeting of the Conference of the Parties:
a) discuss and adopt by consensus its rules of procedure,
including the modalities for significant participation by the
public

- Art. 18: Committee to Support Implementation and Compliance
- 1. A Committee to Support Implementation and Compliance is established as a subsidiary body of the Conference of the Parties
- 2. The Committee shall be of a **consultative** and **transparent nature**, **non-adversarial**, **non-judicial** and **non-punitive** and shall review compliance of the provisions of the present Agreement and formulate recommendations, in accordance with the rules of procedure established by the Conference of the Parties, **ensuring the significant participation of the public** and paying particular attention to the national capacities and circumstances of the Parties.

Significant Participation of the Public COP & subsidiary bodies

All COP meetings and meetings of subsidiary bodies are open to the public



The public can attend, report, and make oral and written statements and proposals



Chair can ask Representatives of the Public to organize interventions from the public



Representatives of the Public have two seats at COP

Culturally appropriate dissemination of information by governments (e.g. national/local radios)
