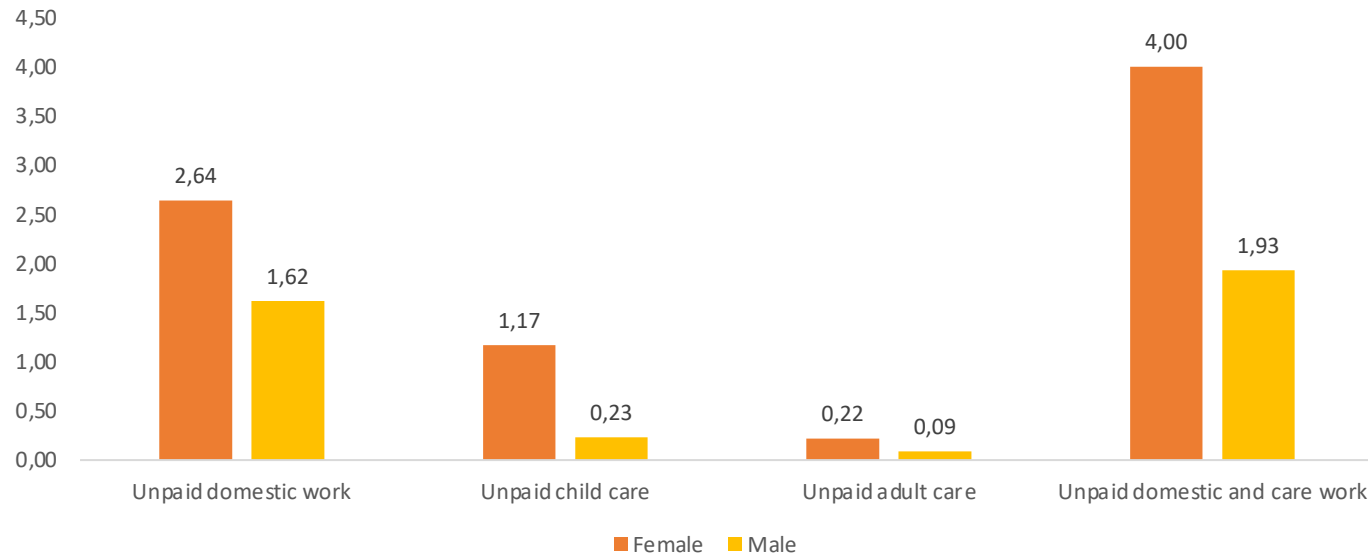

Key Findings

Figure 1: Average hours per day spent on unpaid domestic and care work by sex



- A disproportionate amount of time is spent on unpaid domestic and care work by women and girls, especially on unpaid child care work



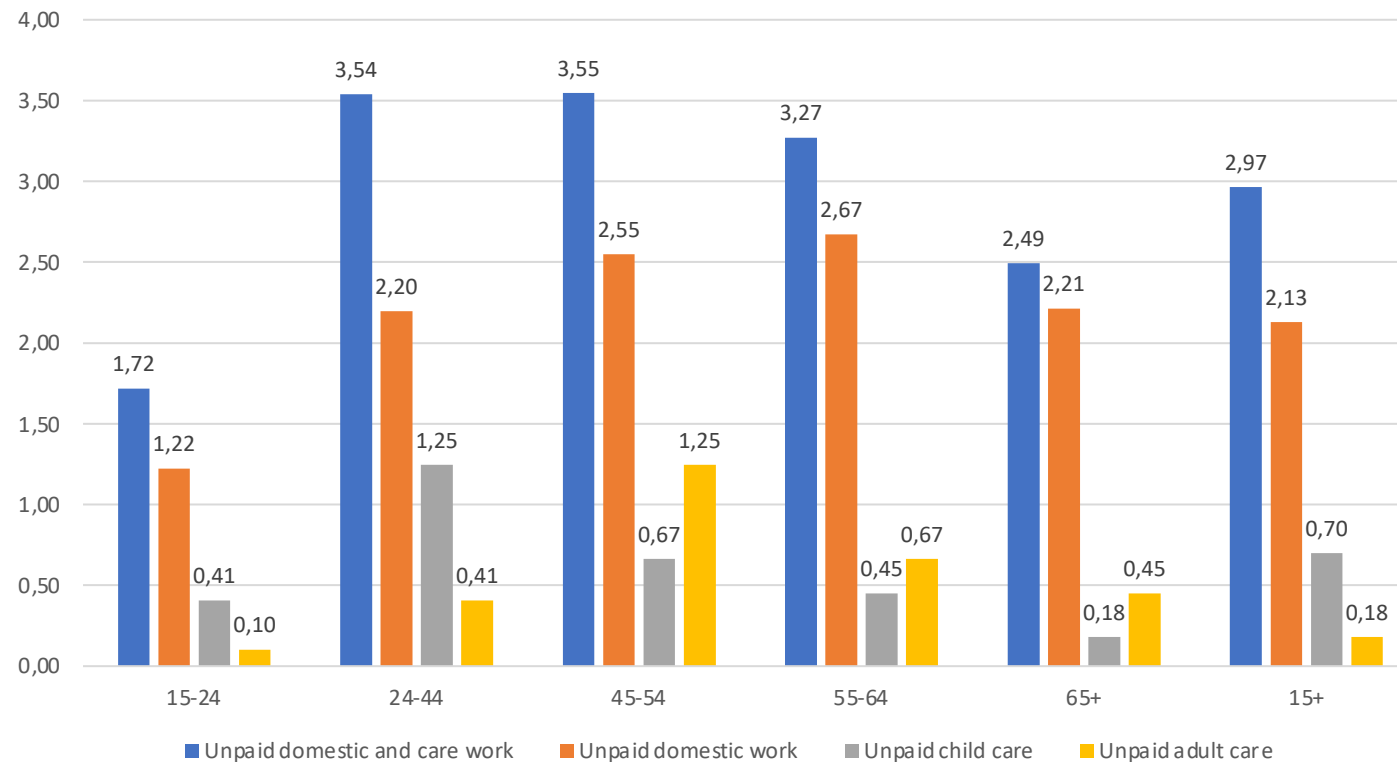

Figure 2: Average hours per day spent on unpaid domestic and care work by age



- Those 55-64 years of age, followed by 45-54 spend the most time on unpaid domestic work
- Those 24-44 spend the most time on unpaid child care, followed by those 45-54
- Those 45-54 spend the most time on unpaid adult care
- Grenadian residents, 45-54 and 24-44 spend the most time on unpaid domestic and care work
