





Current obstacles

- **Identifying goals that digital inclusion is to support**
Disconnect between social policy goals and delivery mechanisms
- **Siloisation of different digital inclusion issues**
Competing and contradictory policy goals and mechanisms
- **Individual responsibilisation and lack of voice**
Rather than collective action to change structural inequalities & Selective attention to rights considered – not involving beneficiaries
- **Digital KPIs for Economic, Social, Cultural and Rights based Development goals**
Lack of a theory of change and associated accountability metrics related to specific groups of beneficiaries
- **Funding where it matters**
No budgets associated with implementation and evaluation for different areas and different beneficiary groups
- **Identifying the right stakeholders**
Go beyond PPPs, and Big Tech/Telcos & Work more with NGOs, human rights, inclusion, and community organisations
