

### Statistical Act

The Central Statistics office is governed by the Census and Statistics Act of 1986.

This act entitles the head of the Central Statistical Office to act as the Statistics Authority for the State and shall be responsible for taking, from time to time, appropriate measures to organize and develop a national statistical system capable of meeting effectively the statistical needs of social and economic planning.

#### The Environmental Statistics Report

- The Central Statistics Office of Dominica produces a report on Environmental Statistics which also captures some of the indicators which forms part or could contribute to the development of the Climate Change and Disaster Indicators.

## Strengths

- Readily available data at some of the sources
- Good working relationship with stakeholders
- Availability of methodologies for the compilation of data

#### CHALLENGES RELATING TO DATA AVAILABILITY

- Inconsistency in data quality
- Low of response rates to data request;
- Difficulty in contacting some stakeholders for information
- Data not available in the required format
- Data gaps

#### CHALLENGES RELATING TO DATA AVAILABILITY con't

- Human and technical resource for the effective compilation of up to date and timely data;
- Lack of policies or if any exist, they are not clear or enforced;
- The lack of hardware and software (for analysis and processing of data)
- Data sharing is not considered "open". (hoarding of data)
