What is an Integrated National Data System?



An INDS is an intentional, whole-of-government, multistakeholder, approach to data governance



An INDS is all about people



- People produce, process, and manage high-quality data
- People populate the institutions that safeguard the data from misuse
- People draft and implement data strategies, policies, and regulations
- People use data for policy design, decision-making, and innovations
- People hold the public and private sectors accountable.





The relationship between an INDS and a national statistical system (NSS)



- An NSS is a core part of the more expansive INDS.
- In an NSS, an ensemble of units jointly collect, protect, process, and disseminate official statistics.
- An INDS, in addition, encompasses data produced, exchanged, and used by other participants including civil society and the private sector.
- The blueprint for building a NSS is a national statistical development strategy.
- The blueprint for building an INDS is a national data strategy.





How can countries build an INDS? A maturity model

- The maturity model is an organizing framework to help ascertain strengths and weaknesses and identify priorities
- It allows countries at different levels of data maturity to take concrete steps towards building an INDS
- It is not a one-size-fit all
- Steps need to be revisited and refined

Possible role of NSOs in setting up and monitoring an INDS



System-wide step

Possible role of NSO

Recognize the importance of an INDS in a high-level strategic document, such as a national data strategy

Lead/co-lead/provide feedback on the formulation of the strategy

Charge a unit with responsibility for overseeing the implementation of the national data strategy

Lead/co-lead/be a recipient of the overseeing and reporting







INEGI has expanded its work program on data and statistics related to crime and victimization in Mexico in response to the growing demands from policy makers and data users.

Palestinian Central Bureau of Statistics regularly disseminates official statistics on important international observances, such as International Workers' Day and International Women's Day.

- Collaboration between the Ugandan Bureau of Statistics,
 Ministry of Education, and the Civil Society ensured that data
 on literacy and numeracy were collected in accordance with
 official educational standards. The data were later used by
 the Ministry of Education.
- In Mozambique the standardization of community scorecards used by several NGOs to assess school and health care services at the local level allowed the data to be aggregated to the national level, where they were used in research and advocacy campaigns.
